SCCRC Fiscal Report – Luann Swanberg, Fiscal Agent Director, SCCRC

- SBCCD serves as the fiscal agent for about \$21 million per year that comes to the region.
- **RCC Grant -** Regional Collaboration and Coordination (RCC), community college and K12 SWP (to include K14 Technical Assistance Provider)
- RCC Economic and Workforce Development (EWD) Agreement
 Addendum #2
 to 22/23 out to extend expenditure period for 22/23
 allocations to June 30, 2024
- New EWD Agreement starting July 1, 2023 June 30 2026 (the end of the 5 year RCC grant). This agreement is similar to the community college (CC) Strong Workforce Program (SWP) agreement. This would only be amended if the allocation model changes.

- Timelines:

- Quarterly reports due the 10th of each month after the end of the quarter.
- Final Report was due at the end of July, but since the expenditure period has been extended, only a 4th quarter report will be required at this time.
- **CC SWP Round 8** coming just don't know when. Assume allocations to be similar to what they were last year.
- Reporting Deadlines: <u>SWP Reporting Update Feb 2023</u>
- **REGIONAL FISCAL OVERVIEW 101** Will schedule a webinar in July, and again probably in the fall
