



 - Executive Council would like information on proposed projects prior to review by the steering committee
 - All plans due in NOVA by October 31st





Credit for Prior Learning (CPL) helps our students complete quality programs faster, increases our colleges' value proposition, and confers significant economic and equity benefits to students, colleges, and the state.
