## • <u>K12 Strong Workforce Program</u> (K12 SWP)

- Currently closing out Round 4 ending June 2024.
- Round 5 ends July 2025
- Currently reviewing Round 6 final plans and budgets, and the 70% advance payments will be made once approved.
- Year 6 K14 Technical Assistance Provider (TAP) and K12 Pathway Coordinator (PC) contracts will be one year (July 24 - Jun 25) instead of the previous 15 month contracts. Going to the SBCC Board in May.
- Regional Coordination and Collaboration (RCC) Grant
  - 2024/2025 Allocations and 70% advance payment will not be made until the EWD funding is approved in the state budget (late July early August).
  - $\circ~$  Katie stated that the Face Sheet states the yearly allocations are based on the funding approved by the state.
  - $\circ$   $\;$  The allocations to each college will remain the same for 24/25.
