## • 2024-25 Funding Allocations per Budget Act of 2024 (SB 108)

- The Budget Act of 2024 (<u>Senate Bill 108</u>) outlines the funding to be made available for the Strong Workforce in fiscal year 2024-25 as follows:
- \$290,400,000 shall be available to support the Strong Workforce Program pursuant to Part 54.5 (commencing with <u>Section 88820</u>) of Division 7 of Title 3 of the Education Code.
- Of this amount, \$5,000,000 shall be available on a one-time basis to support statewide education pathways for low-income workers demonstration project, and \$60,000,000 shall be available to support the Rebuilding Nursing Infrastructure Grant Program pursuant to Sections 88770, 88771, 88772, and 88773 of the Education Code.
- It is the intent of the Legislature to appropriate \$60,000,000 each fiscal year between 2025–26 through 2028–29, inclusive, to support the Rebuilding Nursing Infrastructure Grant Program. As a result of the enacted State budget, the fiscal year 2024-25 SWP funding breakdown has been modified in alignment with the legislation.

### • Economic and Workforce Development (EWD)

- Program Update: The governor has signed <u>AB3087</u> extending the current EWD program through January 1, 2030. Employer Engagement (EE) contracts can now be fully executed. Funding for EE has been distributed to the Regional Consortia for EE projects
- **Centers of Excellence**: The Chancellor's Office has requested that COE grantees submit a Workplan/budget to program staff by September 30, 2024. CO staff is

currently working with the NOVA team to modify the NOVA system with the appropriate objectives and progress questions for COE grantees. COE will now be reporting a progress and expenditure report annually Staff will provide guidance once the NOVA system is fully functional for the COE grantees.
