Final Budget - June 30, 2025

Issue

The Student Senate for California Community Colleges will update the Consultation Council members on the Student Senate for California Community Colleges' (SSCCC) current initiatives, legislative stances, system participation, and board status.

Background

The SSCCC will present the council with an update on actions taken by the SSCCC Board of Directors (Board) since the previous Consultation Council meeting, as well as concerns raised by the Board and constituents, including, but not limited to, legislative updates and the current state of the SSCCC.

Student Senate Priorities

- The SSCCC leaders attended two national conferences in May: the National Conference on Race & Ethnicity in Higher Education (NCORE) in New York and the Education Writers Association conference in St. Louis, Missouri. Both events were informative and garnered SSCCC national recognition.
- The SSCCC proudly co-hosted the Faculty Leadership Institute with the Academic Senate for California Community Colleges this June at the Hyatt Regency in San Francisco. Now in its fourth year, this collaboration welcomed over 30 new student leaders, who joined new faculty leaders in exploring key topics such as participatory governance, the Brown Act, budget processes, resolution writing, and more. This joint institute continues to strengthen shared governance by fostering mutual understanding and leadership development across students and faculty.
- The SSCCC leadership, both incoming and outgoing, held a transition meeting
 June 20 22, 2025, to ensure a smooth and informed handoff of responsibilities.
 During the meeting, outgoing leaders shared key insights, reflected on
 accomplishments and challenges from their term, and provided guidance on
 ongoing initiatives. Incoming board members also had the opportunity to ask
 questions, gain clarity on their roles, and begin building relationships with their
 peers and staff.
- Incoming President, Jerry Reyes, and two other student leaders participated in panel discussions at the ASCCC Curriculum Institute in July at the Ontario Convention Center in Irvine.

Legislative Priorities

The SSCCC is actively tracking and advocating for several key bills as they progress
through the legislative process. Following Suspense Day and recent floor
sessions, our sponsored bill, Assembly Bill (AB) 409 (Arambula), along with four
co-sponsored bills, Senate Bill (SB) 98 (Pérez), SB 271 (Reyes), AB 323 (Fong), and
SB 323 (Pérez), have successfully advanced to the second floor for further
consideration.

 Legislative Affairs Directors from SSCCC participated in several legislative visits, leading virtual meetings with Assemblymembers Jackson, Gonzalez, Boerner, Sharp-Collins, Muratsuchi, and Fong. During these visits, they advocated for SB 323 in collaboration with the University of California Student Association (UCSA) and the California State Student Association (CSSA), representing all three higher education systems and sharing student perspectives and stories.

The SSCCC is committed to providing both in-person and written testimony for these important bills and will continue advocating on behalf of all two million California community college students.

Issue

The Board of Governors is presented with the *Vision 2030: A Roadmap for California Community Colleges, The July 2025 Edition*, a framework for systemwide action to advance equity in access, equity in success, and equity in support for current and future students in the California Community Colleges.

Background

In September 2023, *Vision 2030: A Roadmap for California Community Colleges* was approved by the Board of Governors and launched by the California Community Colleges Chancellor's Office. It was a call to action for the 116 colleges to lead with equity, act with urgency, and serve as a force for economic mobility, environmental stewardship, and social justice. That living document was collaboratively developed to provide focus and direction for the California Community Colleges.

During the preparation of *Vision 2030 – The July 2025 Edition*, Consultation Council Members were invited to provide feedback and impressions during the April and May meetings with additional impressions requested in June.

On July 22, 2025, the Board of Governors will consider a refresh of Vision 2030, not as a change in direction, but as a recommitment to the shared goals. *Vision 2030: A Roadmap for California Community Colleges, The July 2025 Edition* reflects what has been learned over the past 22 months, clarifies the approach to innovation and governance, and expands the framework to incorporate the challenges and opportunities emerging across the state of California, the economy, and the system.

The elements of *Vision 2030 – The July 2025 Edition* remain organized on intersecting goals and strategic directions bringing student access to the forefront:

Goals: 1. Equity in Access - 2. Equity in Success - 3. Equity in Support

Three Strategic Directions remain framing updated Actions:

- 1. Equitable Baccalaureate Attainment
- 2. Equitable Workforce and Economic Development
- **3.** Generative Artificial Intelligence and the Future of Learning

Additional areas of emphases include:

- Reaching every Californian by bringing college to them;
- Engaging in generative artificial intelligence to reshape how students learn, educators teach, and institutions operate;
- Leading climate action to build pathways to a green economy and curricula that prepare college graduates to care for the planet.

Vision 2030 – The July 2025 Edition also captures the system's current momentum and continued commitment to serving California through the following:

• **Demonstration Projects** that are exploratory in nature, designed to build, test, evaluate, and improve, creating blueprints for success.

• Vision 2030 **Workplans** outline activities, timelines, and resources allocated to implement specific goals and actions.

Issue

This item provides the Board of Governors (Board) with a summary of the 2025-26 Enacted State Budget and the implications for California Community Colleges, as well as a brief overview of the 2026-27 System Budget and Legislative Request (also known as the "Shared Advocacy Request") and its process and timelines. Also included are State and Federal Advocacy updates from the Chancellor's Office Government Relations Division.

Background

California law (Education Code Section 70901(b)(4)) requires the Board to provide representation, advocacy and accountability for the system before state and national legislative and executive agencies. The Procedures and Standing Orders ("Standing Orders") of the Board of Governors provide guidance to the Chancellor in representing the California Community Colleges on matters pending before the California Legislature and Governor, Congress and the President. The Standing Orders also authorize the Chancellor to take positions on pending legislation on behalf of the Board, as specified (Standing Orders Section 317).

2025-26 State Budget Highlights for California Community Colleges

Significant economic uncertainty has permeated almost every aspect of the state budget. While 2024-25 revenues are about \$1 billion more than estimated by the Administration in May, recent federal discretionary actions, stock market volatility, and the impact of tariffs are projected to result in slower economic growth. The enacted State Budget includes overall state General Fund spending of about \$228 billion, an increase of about 8% compared to the enacted budget for 2024-25. Additionally, \$174 billion of federal funds spending is projected to flow through the state treasury, but that amount may change significantly over the next few months.

Below are some key features of the final budget adjustments for the community college system:

- Provides \$12 million one-time for the Common Cloud Data Platform.
- Provides a \$10 million ongoing increase to the Rising Scholars Network and removes the cap on district participation.
- Provides \$5 million ongoing and \$15 million one-time to expand credit for prior learning policies.
- Provides \$25 million to establish the Career Passport.
- Defers \$408.4 million from the Student Centered Funding Formula from 2025-26 to 2026-27.
- Provides a total of \$239.9 million across the 2024-25 and 2025-26 budget years to support 2.35 percent enrollment growth.
- Provides \$60 million one-time for a Student Support Block Grant.
- Provides \$20 million one-time for emergency student financial aid.
- Provides \$15 million one-time to support Dreamer Resource Liaisons.
- Provides \$6.6 million in one-time funding to support e-Transcript California.

Each year, the Chancellor's Office invites members of the Consultation Council, the system's Chief Executive Officers, and the Chancellor's Executive Team to submit items for consideration as part of the System Budget and Legislative Request. This document, which will be presented to the Board of Governors for review and approval in September, reflects the major budget and legislative priorities shared by the Chancellor and system partners, and forms the basis of our advocacy for the following year.

Staff will provide an update on the 2026-27 Shared Advocacy Request, including major themes expected for Fiscal Year 2026-27.

Federal Update

Budget Update

On July 1, the Senate voted 51-50, with Vice President Vance casting the decisive vote, to approve its budget reconciliation bill, H.R. 1, *One Big Beautiful Bill Act* (with the House passing its own version on May 22). The bill represents major changes to a wide range of domestic policies, including many that affect students, families, and education systems and institutions. The Congressional Budget Office (CBO) and the Joint Committee on Taxation (JCT) analyzed H.R.1 and estimate that it would:

- Increase the primary budget deficit by \$2.4 trillion over the next decade;
- Lead to higher interest rates, increasing interest payments on the federal debt by \$441 billion over the next decade;
- Leave approximately 11.8 million more Americans uninsured by 2034 due to cuts and structural changes to key health care programs.

As of this writing, the is being considered in the House of Representatives. If the House also approves the bill, it will proceed to the President to be signed into law. If the House does not

pass the exact same version as the Senate's, the bill would require further negotiations between the two chambers of Congress before it could become law.

Federal Legislation

- 1. S.70412: Exclusion for Employer Payments of Student Loans: Allowing employer student loan payments up to \$5,250 annually to remain tax-free for both employers and employees indefinitely.
- **2.** S.70413: Additionally, Expenses Treated as Qualified Higher Education Expenses for 529 Accounts: Allows tax exempt distributions from 529 savings plan to be used for additional education expenses in elementary or secondary public, private, or religious school.
- **3.** S.70414: Postsecondary Credentialing Expenses as Qualified Higher Education Expenses: Allows 529 plans to cover expenses for recognized post-secondary credential programs and cost associated with obtaining recognized post-secondary credentials.
- **4.** S.70415: Modification of Excise Tax on Investment Income of Certain Private Colleges and Universities: The Senate version proposes raising the endowment tax on private colleges and universities and maintaining the tiered structure of the House version. This exempts religious colleges and requires colleges to take on international students of the total roll call when calculating the endowment's value per student.
- **5.** S.71124: Creates Work Requirements for Medicaid Enrollees: Would have ablebodied adults from ages 19 to 64 to work at least 80 hours a month as a condition of eligibility for Medicaid.
- **6.** S.71120: Reduction of Provider Taxes: Would prohibit non-expansion states from increasing the rate of current provider taxes of increasing the base of the tax to a class or items of services that the tax did not previously apply.
- 7. S.70416: Expanding application of tax on excess compensation within tax-exempt organizations: Imposes an excise tax equal to the corporate tax rate on tax-exempt organizations that pay over \$1 million in compensation or excess parachute payments to certain highly paid employees. Allows broadens the definition of "covered employees" to include any employee of the tax-exempt organization who earns over \$1 million, removing previous limiting language.
- **8.** H.R 3943: The Opportunity to Address College Hunger Act: Requires institutions of higher education to inform students who receive federal work-study or who are eligible to receive the Pell Grant that they may qualify for SNAP benefits and giving qualifying students office documentation of their eligibility.
- **9.** H.R.3994: Understanding Student Parent Outcomes Act: Aims to support pregnant and parenting students by collecting data on barriers to graduating college for

pregnant students, student parents, and caregivers. Also connects students with childcare, leave options, and other accommodations at their institutions.

10. S.2036/H.R 3913: Putting American Students First Act: Would prohibit undocumented students from accessing TRIO.

Administration Update

Department of Education

The One Big Beautiful Bill (H.R.1) would significantly impact the Department of Education and has raised concerns about potential effects on critical education programs. These include changes to state funding for schools, reductions in the number of students eligible for free meals, modifications to the Supplemental Nutrition Assistance Program (SNAP), and revised eligibility requirements to the Pell Grant.

Judicial

On June 17, the Department of Education announced that it is referring its investigation into the New York Department of Education (NYDE) and the New York State Board of Regents (the Board) for their unlawful attempt to ban mascots and logos that celebrate Native American history to the U.S. Department of Justice for enforcement. This action comes as the NYDE and the Board rejected the Department's Office for Civil Rights (OCR)'s proposed Resolution Agreement that would bring both entities into compliance with Title VI of the Civil Rights Act (1964) by rescinding its prohibition on Native American mascots and logos.
