❖ **Economic and Workforce Development (EWD)**

The Workforce and Economic Development (WEDD) division review of the Industry Driven Regional Collaborative (IDRC) letter of interest has been completed. The list of awardees has been released to the field. This year's IDRC grant cycle was highly competitive, with 51 strong and innovative submissions received from across the state. The EWD team greatly

appreciates the time, effort, and commitment demonstrated by all applicants in support of advancing workforce education and regional industry alignment.

Unfortunately, due to limited available resources, not all eligible proposals could be funded. We recognize the strength and merit of many submissions and sincerely regret that we were unable to support every deserving application.

The next step in the award process is formal approval of the grants by the Board of Governors at their September 15th meeting. In preparation, communication has begun with selected awardees to request up-to-date contact information.

Following board approval, the EWD team will provide detailed guidance for completing the required facesheets, workplans, and budgets in the NOVA system. The Chancellor's Office IDRC award announcement can be found [here](#).
