California Apprenticeship Initiative (CAI)

Accurate use of SAM course codes (e.g., CB09 = A for apprenticeship courses) and correct student apprenticeship status coding (SB23) is essential for reliable statewide reporting, compliance with funding rules, and proper alignment with DAS registration requirements. Misclassification can lead to reporting errors, missed funding opportunities, and challenges in measuring program outcomes.

Perkins V

- **FY 2026–27 California Perkins V Title I, Part C Funding Allocation and Performance Alignment**
 - The California Perkins V Title I, Part C allocation for FY 2026–27 distributes a total of \$62,920,582 across 72 community college districts, yielding an average district allocation of \$873,897 and a per-student breakdown of \$98.61 based on 638,096 unduplicated CTE students from economically disadvantaged backgrounds. This critical funding is specifically structured to allow local districts to meet the three postsecondary core indicators of performance while driving long-term student outcomes and continuous program improvement. To maintain compliance and secure ongoing eligibility, districts must intentionally align these newly allocated resources toward the federal accountability of metrics. (1P1: Postsecondary Placement and Retention; 2P1: Earned Recognized Postsecondary Credentials and 3P1: Nontraditional Program Concentration).
- **Reminder Regarding Prohibited Use of Federal Grants Funds for Lobbying and Allowable Membership Costs.**
 - Under the Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards (commonly referred to as the Uniform Guidance), lobbying costs are unallowable charges to a federal award. Specifically, 2 C.F.R. § 200.450 prohibits the use of grant funds for lobbying activities, including influencing activities associated with obtaining grants or attempting to influence, either directly or indirectly, an employee or officer of the executive branch of the Federal Government to give consideration or to act regarding a Federal award or a regulatory matter.  - **Consequences for Noncompliance:** Failure to comply with these provisions may result in disallowed costs, audit findings, program reviews, and additional oversight or enforcement actions by the Department up to the termination of your grant.

- **June 30 Deadline:**
 - Statewide The June 30th deadline for Perkins V marks the official end of the fiscal grant year. **June 30th** is the last day to spend, encumber, or liquidate Perkins V Title I-C formula grant funds allocated for FY2025-26. Districts should ensure that any remaining funds have a binding written commitment (e.g., a purchase order) on or before June 30. Districts should gather data for the fourth-quarter expenditure reports and prepare for the final expenditure/performance reports due September 30th, 2026.

- **Title I-C Local Assistance**
 - **July 1, 2026 Funding Release:** Perkins V subgrants and annual allocations for Career and Technical Education (CTE) programs become officially available to 72 community College Districts. Districts begin executing their approved grant activities, purchasing equipment, and rolling out new sequences of academic and technical courses.
 - **July 15, 2026:** Quarter 4 reporting FY2025-26 is due
 - A note to all districts: Failure to submit quarterly reporting in a timely manner will cause delay in receiving reimbursement and may result in a Perkins funding **risk assessment**. The district should reach out to the assigned **regional monitor** regarding any questions and/or concerns regarding this submission date.
- **September 30 Deadline**
 - The final expenditure report deadline for Perkins V (Title I, Part C) grants for the 2025-26 grant year is September 30.
