### 1. Strengthen communication, coordination, and timely decision-making in regional CTE efforts

 Work from these regional goals and priorities in crafting your K12SWP Letter of Intent and Application

#### 2. Enhance participation in CTE Career Pathways between K-16

- Be sure to work closely with your community college to shape "Pathway Improvement" applications
- Be sure to include both early career exploration and a plan to help students matriculate successfully from high school to college
- Include work-based learning if appropriate and possible





# **SCCRC Regional Strategic Goals & Priorities for K12 SWP - continued**

- 3. Reinforce regional leadership and operational partnerships among K12, community colleges, industry, labor, and other workforce and economic development entities to improve the delivery of all CTE efforts.
  - Have robust discussions about how to actually create and maintain operational partnerships that work for students.
- 4. Align K12 and college pathways with local and regional and industry needs and provide support for CTE programs.
  - You must work with current Labor Market data provided by the community college Centers of Excellence to inform pathway improvements.
  - Take advantage of working with the region's industry sector Deputy Sector Navigators when doing this.





# **SCCRC Regional Strategic Goals & Priorities for K12 SWP—continued**

- 5. Create a sustained public outreach campaign for industry, high school students, counselors, parents, faculty, staff, and the community at large to promote career development and attainment and the value of career technical education.
  - Be sure to weave in parent and community knowledge of pathways and pathway improvements. The "community" will include industry.
