- 9:20 – 9:35 AM **Center of Excellence Update**—**PPT attached to these minutes**. Adele Hermann said in that in terms of program recommendations, she is here to provide assistance. If the program will go to the state, the form needs to be completed. She works on an average of 20 program recommendations per month.
 - We need to create a tab on our SCCRC website for COE data**
 - Cybersecurity—Statewide report on labor market analysis and statewide survey results. Highlights—surveyed 385 business across the state and collected data on nine of the most common occupations in cybersecurity. Increase of 14,300 jobs.
 - K12 SWP Initiative—The COEs are partnering with Steve Glyer and COE Director for Inland Empire. Looking at parent, teacher, student surveys that Steve has administered (Orange County Crosswalk Enrollment Tool). The COEs are looking at ten years out for these students.
 - AEBCG—COE is working on LMI for adult ed. They are working with West Ed. West Ed will be doing data and accountability training.
 - Supply gap analysis—Regional refresh will be to furnish supply/demand/gap analysis at a sub-regional level.

Outcomes –

- Employers validate the data. Identify high demand sectors.
- Make sure the information is shared internally at the colleges.
- **Representatives from student services should be invited to the stakeholder meetings.**
- Work-based learning. Inform what the colleges have to offer and see if there is interest from sub-regional businesses. Ask what industry needs from colleges in regard to this.
- Soft skills—we need address it first. At advisory meetings, faculty begin with how they address soft skills. Colleges ask “what are the 4 top professional skills in your industry, then the college comes up with a plan to address it in the classroom. Embed in the curriculum and CWEE.
- How will we meet the gaps? What are the trends? Can the gap analysis go out ahead of time along with 4 discussion questions?
- **The audience needs to feel that there is value added beyond what they typically get.**
