- 9:15 9:30 am Strong Workforce Program Updates
 - 1. Community College SWP
 - a. Alejandro Sandoval of the Chancellor's Office will be on the phone this afternoon for NOVA updates
 - b. Sub-award notification for base funding out this week
 - c. Luann attending meetings in Sacramento, including a Statewide Marketing meeting. Mark Perry, project manager for the statewide Career Education campaign, will be joining our January meeting for a listening session (they are doing these in every region to get feedback on their efforts. The CE Toolkit (is being used by the region. The Toolkit is available for K12 as well. https://careereducationtoolkit.cccco.edu/
 - d. Luann reminded the group to keep NOVA updated as that is where the Chancellor's Office pulls information for the Legislature.

 Regina Blasberg gave an ACUE update – the first cohort ended yesterday. Cohorts 2 and 3 will end in June. Ventura and Santa Barbara

participants will do a celebration ceremony as will COC and AVC participants.

2. K12 SWP

- a. K14 TAP will be hosted at COC. The position will be on the January Board meeting. Then will post for 30 days, and then the hiring timeline begins.
- b. K12 Pathway Coordinators The most recent memo is posted on the K12 tab on the SCCRC website. There are many questions that will be addressed on Wednesday at the Extended Ops meeting. Our region has six positions with Santa Barbara County Office of Education as they were a previous regional CTEIG position.
- c. Round two applications are due December 18th. The Review Team has been identified and they are reviewing Selection Committee applications this week. Training for Selection Committee members will begin in January. Luann will get more specific information about training for the Selection Committee that will be held in January. The region has asked for the Chancellor's Office to send a facilitator for the calibration meeting.
- 9:30 9:45 am Regional Program Recommendations Small work group for program recommendation will meeting at 1 p.m. on December 12th. Vet Tech for VC and Business Information from AVC need to be certified by Luann.
- 9:45 10:15 am Strategic Conversations (JobSpeaker, Job Developer/Placer Support and Coordination, etc.)

JobSpeaker--David Gatewood shared an update on three issues:

- 1. Leadership team—David Gatewood, Margaret Lau, Harriet Happel, so the three sub-regions are represented. Paula Hodge is also on the team as the Regional Director for ICT
- 2. Who should hold the contract SBCC—the contract will be created according to the SBCC contract template.

- 3. Do we have enough funding? Jarleth's contract is actually \$200K, so there is currently enough funding.
- 4. Harriet Happel added that since AHC is also engaging with their K12 partners, it will be a good pilot for the region. JobSpeaker also tracks work-based learning.
- 5. David shared that if a college doesn't choose to implement JobSpeaker right away, there will be an onramp for them later.

<u>LinkedIn Learning</u>—Paula will be working with Melissa Moreno as SBCC has offered to use some of their regional SWP funding to get the LinkedIn Learning project going (\$140,000).

Paula Hodge added that all of the above relates to the Virtual Labs project and classroom instruction for those instructors who use the Virtual Lab.

<u>Job Developer/Job Placer support</u> – Luann asked the group what kind of activities these folks should concentrate on (as there is now extra funding going to support these activities).

- 1. Harriet Happel has met with the dean of their Student Services who oversees the Job Developer at COC. They will use the extra funding to add extra hours for career counselors in the Career Center to help students with resume development, etc. (rather than the Job Developers).
- 2. Valerie Eurman from SBCC said that the funds can be used for mock interviews and other events. Perhaps convening regional workshops would be good. She reminded the group that "career counselor" is something different per college.
- Celine Park added that the Ventura District colleges hold a career week. On March 2nd there will be an industry panel (similar to the CCPT Entre to Employment). They are outreaching to those with disabilities.
- 4. David Gatewood said Job Developers will need help in setting up MOUs. He suggested creating an MOU template. Job Developers need to think with an employer perspective in order to simplify. High school students also need things simplified. Our intake and outtake need to be similar.

5. Luann added that there are funds to hire an outside consultant to work with the region and all of the Job Developers. She asked the group to send recommendations for who should be hired. Harriet pointed out that there needs to be a job description for the consultant.

<u>Perkins V</u>— Robin Harrington has agreed to do a half-day workshop on either January 13th or 14th. Diane Walker shared that there is a public feedback timeline for the state plan. Paula shared that the ICT and Business Regional Directors have held regional advisory meetings and would like to create that for the 3 subregions.

 - 1. Newsletter that could share news & best practices quarterly
 - 2. Interactive map on the website that would show employers, college courses, etc. is the SCCRC website internal or external? If we had a public outreach campaign, do we have an expert?
 - 3. On #2 List as K14, not K16.
 - 4. New strategic goal of: Focus on people, so show more of our regional efforts People-driven and Student-centered.
 - 5. Be more intentional about Job Developer work—put it in the goals.
 - 6. Add to #4 call out credit and non-credit and other modalities.
 - 7. #2—is the most overarching goal. Promote the value of CTE to enhance K14 participation. Re-order the goals. We call it K12, but we only fund K7-12.
 - 8. Themes: What are we doing about contract training, etc. Listen to the business community. Think regionally about specific industry needs and solutions to local problems.
 - 9. We don't have a regional marketing plan. What if we had a regional approach to sub-regional marketing?
