- 1. K12 Pathways Coordinators: Form small application review team to work with the Chairs.

The RCs will convene this group next week to review the two prospective hosts from VCCCD.

John Cascamo asked about the interface between these new positions and the regional Guided Pathways Coordinators. The RCs will work on having the new coordinators meet with the two Guided Pathway Coordinators once all are place.

The Chancellor's Office cannot hold the colleges hostage regarding the outcome metrics of these positions as we have nothing to do with their accountability. The RCs are communicating this very directly on the bi-weekly statewide calls.

2. Input to Executive Council for CEO meeting at the end of Feb: Proposal for reduction in SWP funding, what we would like them to communicate to the CO, what else do you want/need from them in guiding our regional planning efforts.

We need to consider who will be affected. Laureano-Harriet-We need to consider outcome metrics.

Margaret-Keep the colleges funding consistent. We must keep the Job Developers, especially as

they are now intricately tied to the new JobSpeaker project, LinkedIn Learning, and

Career Strategist. Reductions only in the regional Projects-in-Common.

 - We will send the draft plan to the Steering committee by close of business 1/24/20.
 - Margaret added that Academic Senate 2020 Career and Noncredit Institute for faculty and administrators and system partners will be April 30 – May 2, San Mateo Marriott. This might conflict with the May 1st SCCRC meeting to be held at LinkedIn in Carpinteria.
- 4. Review the Job Description for the Regional Job Developer Coordinator/Consultant (see attached).
 - Luann asked for suggestions as to who would be a good Job Developer Coordinator.
 - Alan emphasized that our expectations should include very definite expected outcomes from the consultant who is hired.
 - Margaret added that a good outcome would be an actual battery of metrics (that tie into the Vision for Success) for all Job Developers to report, especially that JobSpeaker will help to record. Harriet said that it will help each campus to better understand the expected metrics, especially if there is a reduction in funding, this will solidify our position as to why the positions are a priority for and the return on the investment for JobSpeaker.
- 5. Quarterly meetings.
 - John said that even though we plan dates at Cambria, there invariably are conflicts. He asked if we should have a "massive doodle poll."
 - The RCs will develop prospective quarterly meeting dates and put into the timeline.
