- 9:10 - 9:20 am** **May Revise Update**
- Luann reported that SWP is looking at a 60% cut on community college and K12 SWP will have a 54% cut on their side.
 - DOF and LAO have sent out analysis and various proposals to change disbursement of funding.
 - Alan added that there was a call for a 10% payout of all state employees. This does not include districts payroll because community college employees are not state employees.
 - Laurie Arnold shared that at a recent meeting it was recommended to keep the infrastructure for SWP should remain in place, so that if there are federal dollars to help the state, the infrastructure should remain intact.
- 9:20 - 9:40 am** **Impact on Campuses**
- Cuesta is already talking about furloughs. They have about 7 CTE classes to be offered in person in Summer. This might change.
 - Antelope Valley College --Laureano reported that no talk of furloughs now, but discussing about whether to go fully distance education for Fall.
 - SBCC --Alan said that they had a virtual town hall yesterday. There will be a \$14 million deficit. Looking at a percent cut in salaries for all employees, hiring freeze, probably few faculty replacements. Challenge is a possible increase in enrollment demand, but they will be limited in any increase in offerings. They are pushing everything they can re: lectures to online. Canceled a number of summer CTE courses. Enrollment growth currently is in transfer courses.

For Fall greater CTE enrollment. New nursing cohort will be Spring 2021 (rather than Fall). Nursing classes for that cohort will also be offered in Summer.

- Allan Hancock College --Margaret said that there is a commitment that there would be no furloughs. Holly added that the CFO reported that there is a push through staff reductions through attrition and not filling vacancies. They are expecting further reductions in August as there could be an August Budget Revise.
- Ventura county K12 area is looking at reductions in positions.
- Ventura Community College District – Robert reported that the hold harmless funding formula will be extended. Moorpark is seeing tremendous enrollment growth (35% increase as of now), so the CEOs are looking at optimal enrollment versus maximum enrollment. The VPs have emphasized that there are no plans now for furloughs, but there is a hiring freeze other than critical positions. There is a lot of advocacy going on for Strong Workforce. Many students who would go directly to a 4-year are now choosing to stay home and enroll at community college.
- CalBright (the 115th online college) is on the table to be cut completely.
- College of the Canyons will not be re-hiring short-term temporary employees or student assistants.
- John Cascamo asked if any of the deans have been in direct contact with their public health departments. Margaret shared that Allan Hancock has been given the ability to schedule courses with labs – those that have been designated as supporting critical workforce. They are implementing protocols based on CDC guidelines. Margaret will share the AHC protocols. **John requested that the deans and CTE liaisons have a separate Zoom soon to see where everyone is. Discussion will be about protocols and practices.**
- Ventura College – Debbie reported that they are using a template for approval by the college and district that will then go to public health. Their nursing director testified to the state for get another extension for increasing the number of simulation hours through 20/21.

Regional Priorities

- **Executive Council**
 - CEOs are advocating for Strong Workforce. Their focus is to keep CTE programs going. They have requested all of the regional dollars, though they are still committed to the Job Developer funding.
 - They will consider a mechanism for colleges to opt in to other projects.
 - The RCs have shared the dean's priorities with the Executive Council.
- **CTE Deans**
 - Margaret reported that the deans were able to determine how essential the SWP funding is. For some colleges, local SWP is used for staff related to CTE with essential skills department. Maintain local share funding at 100%. Maintain Job Developers. If additional funding is still available with regional share, we continue Job Speaker and LinkedIn Learning.

- Planning to work with Regional Directors and colleges to have project updates June 8th – especially as things have changed re: COVID.
 - The June 8 agenda will be out next week.
 - Luann urged everyone to bring NOVA reporting up to date. There are updates to LaunchBoard.
- 10:10 - 10:20 am K12 SWP Updates**
- K14 TAP to be hired by mid-July at COC.
 - K12 Pathways Coordinators hiring in process. There will be an onboarding and training the first week of June.
 - Round 1 grantees are working on progress reports. Round 2 grantees inputting into NOVA.
- 10:20 - 10:35 am Regional Program Recommendations (See next page)**
- Amanda working on keeping things current. Live links on the next page.
 - Regional CTE website updates will be followed by Amanda.
 - No discussion. John Cascamo asked if there were any that still need voting. Those that show “open for review” are open for voting. Regional CTE.org website and sort “under review” to see them.
 - Robert added that when the voting opportunity goes out to Oxnard, there is no one yet designated (as he has moved to Moorpark). Lu clarified that Notices of Intent is local to SCCRC. For the official CTE.org website a person can register. The RC assigns a voting member, so **Lu will assign voting privileges to the new dean. For now, it should be either the CIO, Art Sanford, or Giovanni, the grant coordinator.**
 - There is a two-week window for voting, but once all 8 have voted. It is moved from “under review” to “recommended” when 5 have voted yes, but voting is still open.
- 10:35 - 10:50 am Regional Updates**
- **Regional Chairs Update**
 - The RCs meet weekly with either other RCs or fiscal agents. Extended Ops from the Chancellor’s Office now are held as monthly Zoom meetings.
 - There are statewide marketing efforts underway about staying enrolled in community college as well as urging completing census information.
 - **CCCAOE Update**
 - Robert reported that the Board has been meeting bi-weekly to get a sense of what the Fall conference will look like. Exploring a virtual conference, but still under discussion.
 - Leadership Academy has been pushed to August, but still looking at the two venues as to how to offer the training.

- Robert is on the Advocacy Committee, but nothing to share as yet.
- **COE Update**
 - Adele reported that she has been focusing on sharing accessible data for the deans.
 - The SCCRC website now has links to pertinent statewide COE website.
 - COE is sending out second update on COVID today. They are identifying the key data sets. Adele will send out a regional COVID update next week.
 - Re: sector project. Briefs are available on the regional website. Infographics are with graphic designer and they will be out shortly.
- Laureano asked about north Los Angeles County. The statewide COE director manages the state website and she is working to differentiate LA County for College of the Canyons and Antelope Valley College zip codes. **Laureano asked if they could get more specific reports for these two colleges.** Adele replied that she is aware and is doing more sub-regional reporting. She also uses Workforce Development Board resources. **She can always do micro-regional reports and college immediate service areas.**
- **Regional Directors Update**
 - **Advanced Manufacturing**—Mike reported that he and Irene have pivoted to making PPE through the colleges. There was a huge demand for materials and then ramp up production. At COC Economic Development Division, they are looking at an increase in contract ed. Fee-based and contract education will be a huge demand. **Mike requests that a special meeting be held with the contract education marketing team and ETP.** He is looking at federal grants that could be regional.
 - **Energy, Construction, Utilities Sector** – **Dave Teasdale posted links in the chat for resources. That sector is also looking at federal grants. Colleges should contact him if interested.**
 - **Advanced Manufacturing** – Luann reported that the Statewide Director would be available to do a webinar.
 - **Health** – Irene shared that HWI website is updated regularly. The RDs are getting information out to their regions. Statewide Communities of Practices are starting for CNA, Nursing and Dental. All are invited. The health industry is currently experiencing furloughs. She is hearing that it would be good to have more support for mental health, but nothing concrete. Much revolves around billing. There is a USDA Telehealth grant.
 - **Business** – Gayla reported that their sector is helping business apply for PPP funds. She is curating LinkedIn Learning videos. In the Fall she will be doing an Entrepreneurship Summit focusing on DACA students (virtually).

- Global Trade – there are webinars for 21st century skills related to Global Trade. Continuing work with Chambers, etc to identify skills necessary after COVID.
- Agriculture – Holly reported that they are having a faculty-led Zoom with best practices around labs, etc. Some vice presidents and deans have signed up. The agricultural faculty community is very used to close communication. She is tracking several funding opportunities. There are now community college regional partnership grants. Lu asked if this is something that could be coordinated by the Regional Directors. **The RCs will schedule a separate RD call to brainstorm.** Holly said that there is usually a lead applicant which would be a district with then sub-contracts to other colleges. Holly is willing to work with other RDs around applying for federal grants. She is working on bio-technology which will lead the country out of the recession and will work with Terre Quezner, the Statewide Director.
- **Suggested that the federal grant brainstorm discussion include the SWP Steering committee and K12 as well.**
