- 9:15 – 9:45 am      **Strong Workforce Program (SWP)**
- **Budget Update**
    - Expect full funding for college and K12 SWP. There may be revisions in October once all taxes are in.
  - **New Trailer Bill Language** (See next page)
  - Possible confusion in the trailer bill language concerning “noncredit” and “not-for-credit.” Nevertheless, there is a focus on short-term training and upskilling. **The Regional Chairs (RCs) will let everyone know once they receive clarification.**
    - The Chancellor’s Office (CO) will be doing a pilot. The Academic Senate will take the lead on this. Must advocate with the CO to have contract education count in SWP metrics. The statewide Center of Excellence (COE) is working with the CO to push for the ability to include contract education in the SWP metrics. **RCs will follow up with statewide Technical Assistance (TAP) for Contract Education - Margaret Schmidt and put this on the agenda for the next Extended Ops meeting.**
    - There was also a question as to how to fund the development of these short-term training programs.
  - **K12 SWP**
    - New Regional K14 Technical Assistant Provider (TAP), Dr. Giselle Bice
      - Giselle introduced herself.
      - Luann added that Giselle is updating the K14 TAP Workplan as well as working with the new K12 Pathway Coordinators (PCs) on their workplans.

  - Department of Finance (DOF) Driven Tentative Timeline: Still waiting on official announcement from the CO/CDE with final dates.
    - July: activate Regional Review Team and Selection Committees
    - July 31: Selection Committee Applications Due
    - Early Aug: Review Team finalizes the Selection Committee
    - Aug 20: K12 SWP Round 3 Request for Application (RFA) posted to CO website and opens in NOVA - the online application system

  - All community colleges Perkins applications are in and have been signed off by the region.
  - The next Comprehensive Local Needs Assessment (CLNA) isn't due for another 2 years, but the CO is already starting a new effort.
  - COVID calls are now bi-weekly and have been very informative. The link to the COVID webinars is at the end of the minutes.
    - Luann pointed out the various topics that have been presented at the webinars—information in these Minutes.
    - Antelope Valley College is involved in the [California Virtual Campus](#) (CVC) exchange. They have learned that the actual exchange was going to be more work than originally thought. The rubric for the online classes is a valuable tool that they are incorporating to get classes certified. Antelope Valley College (AVC) has professional development that provides training for online instruction. Ventura College is also part of CVC. Christy Douglas from Moorpark College (MC) reported that MC is also part.
  - CHAT: Diane Walker: In addition to the High-Quality CTE guide that Amanda sent out, fyi, ACTE has been having a series of webinars on each subject that is free to members (\$25 each to others)

- CHAT: Diane Walker: Agree @michael, but trends are valuable.

    - Focused on funding opportunities – Bank of America with possible offer to get populations of color back to work based on fallout with COVID 19. Will affect all of southern CA. Focus on Adv. Mfg, Health, ICT.
    - Seeking National Science Foundation’s Advanced Technological Education (NSF/ATE) grant associated with Allan Hancock, SBCC, Pasadena City, and San Diego focused on nano technology and technicians.
  - Ag, Water and Environmental Technologies- Holly Nolan Chavez
    - Reached out to VCCCD and AHC making connections with professional organization that sponsors student clubs. Hoping to develop internships.
    - Sector just finished CA Ag Teachers Conference which was virtual. Hosted a session about converting labs to online or hybrid where there were 171 faculty in the Zoom session.
    - Hosting another webinar on August 7<sup>th</sup> and will poll to see what topics are of interest. Trying to establish a community of practice for both community college and high school faculty.
  - Business and Entrepreneurship - Gayla Jurevich
    - Working on remote internships with DOD and Nasdaq startups. On the DOD working with cybersecurity firm out of Santa Barbara – students paid \$20 per hour.
    - On August 7<sup>th</sup> doing a training for faculty on [JobSpeaker and LinkedIn Learning](#) – overview of how students use the platform. There will be another training for faculty of how to use in the classroom. In September the training will be best practices.
    - She is building a community of practice broken out by discipline for faculty.

Discussion Items:

- Brainstorm on how to address the new SWP trailer bill language
  - Encourages short-term workforce training programs focusing on:
    - Economic recovery and resulting in job placement. Reskilling and upskilling.
    - Have at least one proven employer partner, demonstrate job vacancies.
    - Use competency-based approaches and apply credit for prior learning.
    - Short term = 4-12 week program
  - Example: SBCC School of Extended Learning, **Career Skills Institute (CSI) Career Recovery Initiative**  
<https://www.sbcc.edu/extendedlearning/career-recovery-program.php>
    - Repackaging of Career Skills Institute and noncredit Short-term vocational courses to market to those who are unemployed.
    - Paula added that SBCC relies heavily on LinkedIn Learning for the flipped classroom model. They are offering for credit and noncredit to allow for repeatability for students. They are looking at JobSpeaker for the noncredit side using mobile app technology.
    - Employers in the area recognize the digital badges that students earn.
- More COVID 19 Restrictions - Now What? Innovative approaches/plans for fall online
  - Laureano reported that AVC is working on apprenticeship program for social services. LA County is looking to build partnerships with the community colleges. **It would be good to invite the representative to one of our regional meetings.**
  - AVC working with construction trades that are reaching out to the college to expand.
  - Paula added that the college Job Developers at each of the colleges are participating in leveraging the JobSpeaker tool. Many good ideas are coming forward and they are doing great work.
  - **Luann suggested that we highlight the work of the Job Developers at a regional meeting.**
  - Monica Phillippe from Oxnard appreciated the Regional Directors who are providing much guidance with curriculum development and work-based learning.

**An act to amend Sections 88821, 88822, and 88825 of the Education Code, relating to community colleges.**

Community college districts, working with their regional consortia, shall expedite the development of targeted credit or noncredit short-term workforce training programs, in accordance with all of the following:

- (1) Short-term workforce training programs shall focus on economic recovery and result in job placement.
- (2) Short-term workforce training programs shall focus on the reskilling and upskilling of individuals.
- (3) (A) Short-term workforce training programs shall have at least one proven employer partner, demonstrate job vacancies, and submit verification to the Chancellor's Office.  
  
(B) For purposes of subparagraph (A), verification shall include the projected number of individuals served, completion rates, and job placement rates.
- (4) It is the intent of the Legislature that, where possible, short-term noncredit workforce training programs should be utilized to be responsive to the workforce training needs of employers, with the ability to transition to credit or noncredit courses and programs upon successful completion of a program established pursuant to this subdivision. Colleges are encouraged to develop workforce training that utilizes competency-based approaches and applies credit for prior learning where possible.
