CA Virtual Campus-Online Educational Initiative (CVC-OEI) - CTE Faculty Resources (Baron Brown, Educational Consultant)

- Building out a fully populated series of online resources through a 5-year grant with the California Community Colleges Chancellor's Office (CCCCO). The Dean is Bob Nash.
- Challenges are unique based on colleges' needs.
- The CO wants to know what resources the colleges have, and they want to share their resources via this online platform.
- The Bay and San Diego regions have shared. The Bay region resources are housed on Canvas and San Diego resources are housed on a google doc. San Diego is driving resources through the County Office of Education, so anyone can access. Resources are broken out by sectors. SD County Department of Education Point of Contact – Jewyl Clark.
- The CVC would like to capture our region's online resources especially because of the needs of distance education (DE) in this online environment.
- Industry has told Baron that they will embrace the students as they have theoretical level of knowledge, but must be tested and may enter the



- apprenticeship pipeline at a different pace. Students must have hands on in order to accelerate and must accrue the same number of apprenticeship hours.
- Baron Brown, Educational Consultant for CCCCO CA Virtual Campus-Online Educational Initiative. Our focus is to obtain online resources and best practices for CTE faculty and stakeholders, and place them in a central repository on the CCCCO website. 9:15 – 9:30am Brief updates on fall status - Community College and K12

- Moorpark College is about 90% online with some CTE on campus.
- COC has CTE coming on campus for their labs with all instruction 100% online.
- AVC is about 98% online. Laureano is now assigned as the Palmdale campus Dean and will continue as the AVC voting dean. He will also oversee contract education. Laureano asked about the requirement that vendors providing training be ADA compliant. ANSWER: Margaret Schmidt is the Chancellor's Office Technical Assistance Provider for Contract Education (contact info below)
- Harriet mentioned that JobSpeaker will become even a more important tool in order to track employment, internships, etc.
- From Diane Walker: Our district has also curated resource sheets by industry sector. (San Diego Center of Excellence) SDCOE's resources are awesome! SDCOE is also doing a CTE Instructor Network of virtual meetings, and a conference 10/14-10/15/20
- From Christine Petrone: Jewyl Clark from SDCOE
- From Tiffany Carson: Santa Barbara Unified is implementing fully remote, online learning. We are monitoring the requirements from our state and county to see if we can begin a hybrid model.
- From Diane Walker: For K-12 in any county on a watchlist, we have to be online unless a waiver is issued for TK-6
- From Monica Phillippe: Oxnard Union High School District: On-line learning with the hopes to return to hybrid model for lab meets
- From Kimberly Hoj: Ojai Unified is also doing what SB Unified is doing
- From Debbie Newcomb: VC is about 94% online with only some Career Ed
 (CE) lab programs and a few science labs on campus
- From Armine Derdiarian: At OC all didactic courses are online. CTE
 programs including Auto, Culinary, and Dental labs are in person with
 social distancing and safety measures. Some science labs are also in person
 to accommodate the dental hygiene pre-requisite requirements.

- Request for Proposal (RFP) process and timeline Luann mentioned that the
 region does have an RFP form which is on the website. She displayed the
 graphic depicting the process flow for RFPs requesting funds for regional
 projects. It will be posted to the website, and added to attachments for these
 Minutes.
- NOVA Updates and Reporting
 - All projects need to be input, updated and reported on in NOVA as the data system for SWP, K12 SWP, Adult Ed, Perkins and soon for the Regional Chairs, Regional Directors and Centers of Excellence.
 - Margaret shared that they are still able to close out local projects, but no ability to close out regional projects.
 - Luann said that she has not closed out regional projects because if the budget isn't closed out to zero, it shows as unspent funds. Luann will check on closing out regional projects on the fiscal agent call next week. ANSWER: Recommended on the statewide Fiscal Agent call on 8-26-2020 not to close out projects No need really. But if you do, the budgets do need to be zeroed out or they will appear as budgeted but unspent funds.


