#### MINUTES

#### ACTION ITEMS HIGHLIGHTED IN YELLOW

- 9:00 – 9:10 am **Welcome and introductions.** Attendee list at the end of these minutes.
- 9:10 – 9:45 am **Dr. Julius Sokenu**, Interim President at Moorpark College spoke on his work with the statewide CEO Racial, Equity and Inclusive Excellence Taskforce and how MC is responding to Chancellor Oakley’s Call to Action. Q & A followed.

  - Sharing the relationship of local to statewide efforts.
  - Held a Town Hall on how the Moorpark students were experiencing the call for social justice and racial equity after the George Floyd, Breonna Taylor, and Ahmaud Arbery incidents.
  - Move away from compliance to social justice with a campus-specific focus. Audit the campus climate.
  - Formed social justice work groups and identified 4 themes – diversify curriculum, diversify hiring, provide leadership on racial issues, provide culturally responsive student services. District Board of Trustees Resolution calling for this.
  - Each work group has student, faculty, staff and administrator lead.
  - Assemblymember Jackie Erwin will be speaking about AB705 in a webinar sponsored by one of the work groups.
  - Leadership matters. Took the system Call to Action and made it their own.
  - Julius represents our region’s CEO group on the Chancellor’s DEI Call to Action. He shares information with the group each month. Boards are revising policies through an equity lens.
  - In order to really make change, must step out of our comfort zones.
  - Need to integrate to innovate.
  - CTE is equity.



### Q & A:

- Do students get a stipend for serving? Not at this time. The question is being considered. They have gone to various student groups to recruit new students to these work groups. Look at how to grow leaders in respective groups. This is an equity issue as those that don't have to work have more time to serve while others can't because they need to work so they money coming in.
- Does Moorpark use Launchboard? They use data and information from all data sources. They want a dynamic and robust data set. For example, how are our students of color doing in CTE? Now they know where to put their resources. Students in CTE are doing better than the general student population. Luann asked to see the Diversity Dashboard. Adele will check on this and share back with the region.
- Concern that we don't label people. How do we prevent "them against us?" We start by saying that race is charged. We must be solutions-driven. Where do we invest energy? We need to look at the workplace that our students will be in, and they need to be able to navigate the diverse workplace.
- What are your suggestions for beginning difficult conversations? You must first be willing to have the conversation. Create the environment where people can speak their truth. Ask "who is not here who should be here?" Analyze the data. Their English department is doing an equity gap analysis.
- Value and embrace differences.

### **Diversity, Equity & Inclusion;** sharing of best practices around the region

- CCCAOE Board just did an equity workshop. Each person has their own starting point and history that is brought to the table. Must listen to how students identify themselves. Communication is so important in this work.
- Moorpark has had much professional development in the DEI area. There are 6 people each month attend an e-convening. Passion propelled conversations, but there are ground rules.
- The Chancellor's Call to Action didn't have CTE represented specifically. Could CCCAOE be at the table? How is the work being disseminated? CTE Deans are in the law enforcement group, and in the full DEI integration. It is important that the organizations that are seen as significant get called to the table. but at the end of the day, the opportunity to make change happens at each campus. How are the career programs engaging DEI work?
- Upcoming CCCAOE conference is built around the DEI agenda. There are now CEO and CIO strands. CTE is a vehicle for equity.
- CTE students do well because they are also connected to the program lead. They have a very well mapped out pathway.

- Notices of Intent (NOI)- There are 2 new NOI’s submitted from SBCC since our last regional meeting of 1/22/21. All can be viewed [HERE](#).
  - Court Interpreting COA
  - Medical Interpreting COA
  - Question about removing NOI’s that are no longer being pursued from the Excel list. Suggested to hide the notes description and keep it on the list. Also need to confirm the shelf life of a NOI. Luann said it was discussed at a previous meeting and will look to confirm what was agreed upon.
  - Is there a formal process of notifying RDs when posting a new NOI? The form on the website is supposed to go to all of the deans in addition to the RD in the sector. This hasn’t been consistent, but Amanda will do this going forward. Suggested to use the list of CTE deans, RDs and CTE liaisons.
  - As a group, we can talk about discontinued NOIs.
  - Luann mentioned that it might be time to offer another training on this.
  - The Architectural Drafting degree and certificate of achievement will be moving forward from Allan Hancock.
- NOI for Noncredit (informational only- included in above link)
  - Moorpark is in the process of completing 4 noncredit certificates of completions.
  - There is a Solar Tech 49.5 hour program that has received local approval to offer as soon as summer. There are 3 certificates of completions under Maker Space.
  - For short-term vocational noncredit programs, LMI is required.
- Adele and Drew are working on an LMI template for NOVA 2.0 input. Two-year-old data is acceptable.
- Suggested to change from Participation Agreements accompanying the invoice and instead attach a copy of the NOVA 2.0 plan as backup. Luann will double check with SBCC fiscal to see if anything needs to be signed.
