- 2. Presentation: Association for Career Technical Education (ACTE) Giselle Bice, K4 Technical Assistance Provider (TAP) and K12 Pathways Coordinators (PCs)
  - Giselle introduced Lodene Blair as the new Pathways Coordinator in Santa Barbara.
  - Each K12 Pathway Coordinator (PC) spoke briefly about their specific service areas as a dry run of the presentation they will be doing at the ACTE Conference in early December .

"Bridging the K-14 CTE Talent Pipeline" Conference Presentation - 12/2/21 2:00PM (Pacific) The K12 SWP initiative intentionally supports cross-system partnerships between K-12 and community colleges, or intersegmental partnerships, to develop an education and workforce development student pipeline through strengthened K-14 CTE course sequences, programs and pathways. K12 SWP emphasizes vertical curricular alignment in K-14 CTE programs of study between LEAs and community colleges. Learn how the South Central Coast Region is supporting CTE throughout their region through state funding, outreach to LEAs via Labor Market Data, facilitating dual enrollment and articulation, targeting special populations, and CTE mapping.

- b. Round 1 Close out (Dec 31, 2021 end of performance period)—Luann added remarks about the ability to encumber funds to 11.31.21. There should be a close-out memo from the Chancellor's Office soon and SBCC as fiscal agent will also have a memo.

# 4. Update on Regional Collaboration and Coordination Grant—Luann Swanberg

- a. Conditional funding for one year to all regions in the state.
- b. Feedback received from the Chancellor's Office (CO) for revision (see email to CTE deans and application writing and presentation team) to the plan due April 15, 2022
- c. Dec 7, 2021 meeting with the CO on regional-specific feedback regarding revisions to our plan. Several of the Region's CEOs will also attend the meeting.
- d. Status of the recruitment for the new Regional Executive Director—the position will be housed at the Ventura County Community College District with Dr. Cynthia Herrera, Vice Chancellor, as Supervisor of Record. All CEOs will be invited to be on the hiring committee. From College of the Canyons all the colleges in the region should be involved in the process and if a CEO cannot participate, the CIO from that college should be invited. This will be communicated to Greg Gillespie.
- e. Facilitated Strategic Planning starting in January to collaborate on revisions to the plan and the college and regional employer engagement plans going forward. Luann shared that CauseIMPACT is the consultant that has been selected based on input and experience with them and their work with the Workforce Development Board and others from the VCCCD and Cynthia Herrera as the new Executive Director's (ED) Supervisor of Record and approval from the Executive Council. The Statement of Work has been shared with all of the CEOs for feedback This is to set the region and the new ED up for success and they can hit the ground running. Harriet Happel of CoC asked if any other consultants were considered and the answer was no.

### 5. Discuss Regional meeting dates

- December 10 would the group like an in person meeting—suggested to have a hybrid meeting.

  Dave Teasdale offered to cover the expense of the additional audio and visual technology costs.
- January date(s) for facilitated in-person strategic planning around RCC and Employer Engagement specifically—suggested not to hold the strategic planning meetings until after the new Executive Director is hired.
- February date 2/11 and 2/25 are options
- March 11 or 18 (Spring Breaks this month)
- Apr 6 or 7 (at CCCAOE)
- May 20
- June (Juneteenth is the 19th)—does the group want a June retreat meeting? No vote taken. Possibly make the retreat decision once the new Executive Director is hired. Some colleges will close on June 20th, but the previous Friday will be okay.

# 6. Community College SWP Updates

**a.** Close-out of Round 4 (Dec 31, 2021 end of performance period)—Luann reported that FAQs have not been updated as of today, but below is from Alejandro Sandoval of the CO to the Bay Area Regional Chair Luann read verbally.

Q: When are funds considered obligated for the purposes of meeting the 12/31/21 expenditure deadline for the year 4, 2019-20 allocation of Strong Workforce Funds?

A: The following table establishes when Strong Workforce Program funds are considered obligated. As with all fiscal matters, local policies must also be followed.

Funds obligated as defined in the table above may be reported in NOVA as expended and may be considered by the fiscal agent as approval to honor invoices from grantees claiming obligated funds as actual expenditures.

- There will be a memo sent on behalf of the state's fiscal agents asking for the guidance memo. Comment that funds will be withheld with 22/23 year if funds from Round 5 not fully expended.
- Question about whether the Region has a process to reallocate Round 4 unspent funds. All colleges must communicate individually with Alejandro Sandoval at the Chancellor's Office regarding the request for a spending extension for Round 4 for both local and regional funds. Luann added that colleges should put the specific project number from NOVA on their requests to make it easier for Alejandro to find the project.
- Luann asked the colleges represented on the meeting if they will be able to fully expend.
- COC have plans to fully expend
- AHC will fully expend, but problem with R5 expended on time
- VC same as above
- Luann will re-approach Alejandro for a blanket extension request. The next zoom meeting with him is on December 7th. Request that Alejandro begin to attend our regional meetings.
- **b.** Round 6 Spending Plan and Sub-Award Notification Luann reported that spending plan has been sent out and sub-award notifications to fiscal offices will be out by first of December.



c. Jobspeaker/LinkedIn Learning Regional Project—There are two projects: (1) Jobspeaker/LinkedIn Learning is an opt-in project (4 colleges have opted in); (2) part-time Career Connect project manager was approved by SWP as a Project-in-Common. From College of the Canyons—this project manager is not part of the RCC grant funding. As of this meeting, the project manager is not part of the new RCC grant organizational structure. The position could become an official part of the structure depending on the December 7<sup>th</sup> meeting with the Chancellor's Office regarding revisions to the RCC application.

Question about how colleges that do not opt in to Jobspeaker get served by the Career Connect Project Manager. Answer from Harriet in the chat: They benefit by the Career Connect Employer database that originates out of JobSpeaker and allows for exports from other platforms for those colleges that have decided not to opt in so that the interface employers across the region is one database: Career Connect. All the employers know is Career Connect. This database also allows us to capture the data for WBL, internships and employment.

- 1. The employer survey is ready to go. The regional results from the survey that they can then take to their respective advisory groups. Each college can then report both regional and local feedback.
- 2. Adele reported that there are more than 8,500 unduplicated companies and 24,000 contacts. Results by the end of February. Contact Paula Hodge to add other contacts.
- Contract Education Dave Teasdale Dave reported that interviews are being conducted with the colleges in the Region. There are challenges in terms of resourcing.
  - 1. A Toolkit is being designed that will include a Directory of regional contacts. John Milburn is developing a training for regional practitioners.
  - 2. Both College of the Canyons and the Kern Community College Districts have applied for the new state ETP funding. There will be an incumbent workers training needs survey.
  - 3. There will be marketing materials created.

# c. Regional Directors

<u>Adv. Mfg</u> (Michael Bastine) - Over 3,000 students served by industry talking about mfg opportunities. 32 volunteers for the events. There are 15 robotic teams. Recruiting for the Uniquely Abled program.

<u>Business</u> (Gayla Jurevich) - Reported about Cal Poly elevator pitch with dual enrolled Cuesta and Hancock students. COC had two students selected to be interviewed by Nexus Edge Citibank. With licenses, students get certifications from the businesses.

<u>AWET</u> (Dave Teasdale) – Web-based work-based learning mobile app that has short videos, wage data and links to colleges. This was accepted at the ACTE conference. It has now spun off to an all-sector version—Spotlight on Ag is the app. Received federal approval for apprenticeships for the Chef Ann project starting in the Spring. Must be prepared to train clean energy technicians.

<u>Health</u> (Irene Ornelas) - Irene is wrapping up SWP funding and reporting. Working on Peer Support training that leads to a certification course. She will stay on part-time in the Spring to wrap up the Behavioral Health grant. Many employers looking to expand their workforce to undergraduate students. A Toolkit has been developed on creating Behavioral Health for high school through community college.

- e. **Center of Excellence**—Adele Hermann shared that Launchboard has been updated to 2019/20 data. CTEOS data is 18/19. Adele is working with Ventura Workforce Development Board (WDB) on Clean Green jobs. Adele will be collaborating with Irene on the Behavioral Health study. She is. Supporting Antelope Valley College regarding the Aspen competition. She asked other colleges to reach out to her. Luann added that five of the 18 colleges in California up for the Aspen award are from our region.
