- Community Economic Resilience Fund (CERF)
- K16 CERF Fund—Holly prepared a written document that is appended to these Minutes
- Recent Chancellor's Office Presentations

9:15 - 9:25 am Fiscal Agent Director Update - Luann Swanberg

- Community College Strong Workforce Program (SWP)—
 - Closeout of R1-4 going on now. Asked for fiscal reporting to be done as soon as possible in NOVA.
 - Our region is approximately 86% expended for R1-4 for regional funds.
 Very little of Round 5 has been expended and the performance period ends
 June 30 so request an extension if needed. Some colleges are underbudgeted for R6. Must account for the augmentation in NOVA.
 - K12 SWP—closing out R1 now. Continuing with R2-4. The K12 Pathways Coordinators (PC) and K14 Technical Assistance (TAP) contracts are going to the June SBCCD Board. These are 15 month contracts (July 1 - Sep 30, 2023).
- Regional Coordination and Collaboration (RCC) Grant -
 - The RCC funding is made up of Perkins 1B funds for the Executive Director position and the Economic & Workforce Development (EWD) funds which go to each college for Employer Engagement (EE). An amendment will be sent forward to the SBCCD Board in July to extend the end date of the EWD contracts from Dec 31, 2022 to June 30, 2023.
 - Question on when R7 will be released. The allocation will go out in November, but the release of information regarding allocations will be coming out soon. Recommendation from Vice Chancellor, Sandra Sanchez is to plan on 90% of the R6 allocation (base and incentive.)
 - Employer Engagement plans are due to Holly by June 22. Once the plan is accepted, colleges can invoice for their EWD funds.
 - Employer Engagement Plan Template is available on our website.



9:25 - 9:35 am Chancellor's Office Update - Regional Project Monitor, Katie Gilks

- If any extensions for R5 are needed, send Katie a brief narrative about the request for extension also reach out with NOVA issues, at kgilks@cccco.edu. If a longer term extension for R5 is needed, the CO might hold some R7 funds back until R5 is closed out.
- Dean Ionna Iatridis will be leaving at the end of June and Dean Gary Adams will be taking on EWD for the unit. LaCandice Ochoa has been promoted to the Dean's position replacing Ionna.
- Katie Gilks monitors Perkins, SWP, nursing, K12 SWP, and some Adult Ed.

Regional K-16 Education Collaborative – Planning Grant due September 1, 2022 \$100,000 - \$250,000 planning award, up to \$20 million for implementation grants

This program provides funding for new pathways to careers as part of a statewide effort for strengthening education-to-career pathways, and ensuring that education, vocational, and workforce programs provide broader access to employment opportunities for all students. A total of \$250 million will be awarded in all 13 CERF regions with the first \$108.6 awarded last month for six regions each receiving \$18.1 million each. The program requires participation from at least one UC campus, one CSU campus, one Community College District and one K12 District. The Central Coast CERF region has not yet submitted a proposal. UCSB, UCSC, and WestEd are leading the proposal planning process. The application for the next round of planning grants will be released on September 1st with applications due on October 28, 2022.

It is important that our regional colleges have a voice in the planning process for this important opportunity to transform and improve education and workforce efforts.

<u>Community Economic Resilience Fund –</u> <u>due July 25, 2022 - \$5 million planning</u> <u>grant</u>

This program will award a total of \$65 million to the CERF regions as a workforce development effort to bolster economic resiliency and increase access to quality jobs. Each proposal requires stakeholder participation from labor, business, community groups, local governments, economic development entities, and educational institutions. Proposals are due on Monday July 25, 2022 with notices of intent due June 22nd. The SCCRC has counties in both the Central Coast and Los Angeles CERF regions. The initial planning grants will provide \$5 million dollars for each region. I am meeting with regional WDB's, Ventura/Santa Barbara EDC, REACH, and Monterey Peninsula Economic Partnership

NSF Regional Innovation Engines (NSF Engines) – LOI June 30 - \$160 million

\$160 million NSF Engines proposal being developed by UC Ag and Natural Resources as part of a statewide submission titled "The California Climate Smart AgriFood Innovation Engine". This new program is a ten-year grant supporting workforce development and market commercialization and technology support for colleges. Activities will support food production and innovation including AI, Robotics, Synthetic Biology, and Food Tech. Activities will be targeted on the Central Coast, Inland Empire, and Central Valley.
