9:05 - 9:15 am Executive Director Update - Holly Nolan Chavez

- Employer Engagement (EE) plans all submitted, and payments to colleges for Jan. June 30, 2022 Employer Engagement subcontracts are being processed for each college.
- New addition of dedicated monthly meeting time for our K12 partners (usually Weds before our monthly regional mtgs). These meetings will be open to all interested parties and will focus on K12 topics.
- Ongoing planning grants: CERF (California Economic Recovery Fund) We have 2 regions that overlap with the SCCRC (Central Coast and L.A.). The planning grants support economic development and job creation due end of July.
- Ongoing planning for the regional K16 education grant (\$18M) for the central coast CERF region. Important for the community colleges to have a voice in the planning. This grant is due in early October.
- Regional Executive Council settled on Steering Committee needs:
 - Make funding recommendations around Community College strong workforce, regional projects.
 - Representatives will be appointed by the CEOs, who will make Round 7 Strong Workforce Program (SWP) funding recommendations.

- Community College Strong Workforce Program (SWP)
 - NOVA is open for FY 22-23 to begin planning for local & regional projects.
 - Round 7 allocations unknown; plan for 85% of last year's allocation
 - Rounds 1-4: Closeout in NOVA.
 - Would appreciate all quarterly reports entered as soon as possible so we can get a clear picture of expenditures.
 - A couple of colleges still need to budget for regional Round 6 Augmentation dollars in NOVA.
 - All local and regional budgets and expenditures should be input into NOVA prior to November or risk a delay in Round 7 funding.
- K12 Strong Workforce Program (K12SWP)
 - Closing out on Round 1; Active Rounds 2-4
 - Reporting-04 due at the end of July. Please reach out with questions.

K12 Strong Workforce Program Update - Giselle Bice, K14 Technical Assistance Provider (TAP)

- K12 SWP will have separate mtgs for Local Educational Agency (LEA) grantees and K12 partners that include professional development, NOVA support, fiscal updates, etc. All are welcome to attend, but focus will be on K12 SWP.
- AB2058 legislation to move K12 SWP to California Department of Education (CDE) has not passed at this time. The California Community Colleges Chancellor's Office will continue with Round 5. We have regional funding parameters and the K12 Round 5 Selection Committee (SC) has already formed. SC Chairs being finalized.
- Staffing update: Antelope Valley Union High School District (AVUHSD) has new Pathway Coordinator (PC), Teresa Howard. Santa Barbara County Education Office (SBCEO) has Matt Zuchowicz.

Chancellor's Office (CO) Update - Regional Project Monitor, Katie Gilks

- Governor's Budget was signed and K12 SWP remains with CO.
- Plan for 85% of last year's allocation as you prepare your plans for community college (CC) SWP funds.
- Some delays in funds going out to field—to be released in Q1.
- Still time to get in CC R5 reports. Drop dead date is Oct 15th or funding impacted.
- Regional Collaboration and Coordination Economic and Workforce Development (EWD) funding: Extending the EWD program another 5 years through 2028. Another allocation for \$22.9M for FY 2022-23.
- K12 SWP: K12 PC and K14 TAP NOVA system opening next week as they are working through glitches.

- Harriet Happel: COC has Successfully incorporated Contract Ed with Northrup Grumman (etc.); On advent of third cohort; these trained students are getting employment at 100%! Very exciting. Using a CRM (client relationship management) system (B2B Engage) as a database for all departments and partners to use -- both profit and nonprofit. General Ed and Career Ed integrating project-based learning. E-portfolios via PebblePad. There is constant communication. Employers get one message from the college. Paula Hodge as EE Director has her feet in both Contract Ed and instruction.
- John Milburn, Director of Business Partnerships at College of the Canyons: Justin Wallace works closely with Harriet in credit and with John in noncredit. Integrating not-for-credit is a new and different way of engaging.
- New Contract Ed website created by Ron and Barbara Sweet. Target audience is for practitioners, not businesses.
- John, in partnership with the statewide contract ed practitioners group, has developed a website at www.UpskillCalifornia.com.
- Ron: Goal of toolkit is to share content, information, and resources including revenue sharing models. Spreadsheet will be sent to each college to be able to add to directory with all colleges, not just College of the Canyons.
- Contract Education addresses Goal 3 of the Employer Engagement matrix.
