# Legal Advocacy Baccalaureate Program Proposed Curriculum

**Program Name:** Legal Advocacy

**Program Description:** The Legal Advocacy Baccalaureate Degree features an interdisciplinary approach to representing people, ideals, and organizations in a complicated legal and governmental system. Students will be exposed to and develop skills in persuasive and intrapersonal communication, understand the policies, socio-political norms, bureaucratic demands, and cultural attitudes that will aid them in seeking redress and obtaining positive outcomes for their community, and will learn how to utilize skills required to ethically lead and advocate for people and organizations. Participants in the major course of study will focus on the development of collaborative, intersectional environments emphasizing leadership and service and how advocates can benefit socio-cultural change and attitudes in order to empower people and address both systemic issues in underrepresented groups and private issues for individuals in need.

### **Program Outcomes:**

Upon successful completion of the program, students should be able to:

- A. Understand the legal and governmental systems in which society operates and how to carefully navigate nuance in approaches to advocacy therein.
- B. Understand and utilize leadership skills to drive teams forward together and obtain positive outcomes for stakeholder groups.
- C. Evaluate both individual and institutional needs/standards and how to approach issues on a case-by-case basis using historical context and experience to temper plans for advocacy.
- D. Navigate complex societal structures and governmental bureaucracy in order to effect change.
- E. Identify social problems and issues and strategize/plan effective solutions
- F. Collaborate within and without an organization to achieve heightened success, share resources, and enhance solution-oriented decision-making processes.
- G. Research, interpret, synthesize and apply relevant legal, factual and ethical matters in the practice of advocacy.
- H. Apply creative thinking, analysis and judgment to generate appropriate responses to legal and ethical issues and problems in the practice of advocacy.
- I. Communicate effectively, concisely, persuasively and in a professional manner, using oral, written and non-verbal communication in the practice of advocacy.
