## 2023-24 Funding Formula

Perkins Title IC funds are distributed to eligible community college districts based on their share of unduplicated headcount of disadvantaged students who are enrolled in career technical education (CTE) programs.

## Purpose of Funds

The purpose of these funds are to: prepare special populations' student groups for high-skill, high-wage, or in-demand industry sectors or occupations that will lead to self-sufficiency; prepare CTE participants for non-traditional fields; provide equal access for special populations to CTE courses, programs and programs of study; and ensure that members of special populations will not be discriminated against on the basis of their status as members of special populations.

Special populations' student groups mean: individuals with disabilities; individuals from economically disadvantaged families, including low-income youth and adults; individuals preparing for non-traditional fields; single parents, including single pregnant women; out-of-workforce individuals; English learners; homeless individuals; youth who are in or have aged out of the foster care system; and youth with a parent who is a member of the armed forces and who is on active duty.

## 2023-24 Spending Guidelines

Districts must obligate all funds by June 30, 2024. In addition, under the Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards (Uniform Guidance) at 2 CFR § 200.344 (b), grantees must liquidate obligations within 60 days of the end of the funding period, unless an extension is approved by the Chancellor's Office. Each district is responsible for accounting for the expenditure of the 12-month grant allocation. Perkins V funds cannot be carried into the following fiscal year.

Required reporting is submitted within the Chancellor's Office grant management system NOVA:
