The Master Agreement (“Agreement”), was entered into February 1, 2017 between Santa Barbara Community College District, hereinafter referred to as “District,” at 721 Cliff Drive, Santa Barbara, CA 93109, and the districts listed above (collectively “Sub-Grantees” and individually “Sub-Grantee”). The District and Sub-Grantees are also referred to collectively as “Parties” and individually as “Party.” The Strong Workforce Program Agreement between District and the California Community Colleges Chancellor’s Office is effective to cover activities beginning February 1, 2017 and ending December 31, 2025.

RECITALS

WHEREAS, this Addendum will change invoicing and payments parameters from total 100% regional allocation payments with certified NOVA plans submitted with invoice, to 70% advance with certified NOVA plans, up to a 20% progress payment with NOVA fiscal reporting completion, and a minimum 10% final payment with NOVA fiscal reporting completion.

NOW, THEREFORE, by the signatures of each Party’s authorized representative below, the Parties agree to the terms set forth in this Addendum, which terms and conditions, upon such signatures, shall be incorporated into and become part of the Master Agreement between Santa Barbara Community College District and the community college districts mentioned herein and binding upon the Parties without any further action by the Parties.
